On 23 July 2024 the Statement of Investment Policy and Objectives was updated to:

- Change the investment objectives for all funds from "aiming to achieve positive long-term returns" to "aiming to achieve long-term returns before fees, taxes and other expenses greater than a specified benchmark".
- Update the asset allocation targets and ranges for the multi-asset class funds.

On 1 October 2024, the custodian of the Scheme was changed from Trustees Executors Limited (acting through

its nominee company T.E.A. Custodians Limited) to Apex Investment Administration (NZ) Limited.

On 1 October 2024, unit pricing and fund accounting services were transferred from Trustees Executors Limited to Apex Investment Administration (NZ) Limited.
