What is the purpose of this update?

What are the risks of investing?

Risk indicator¹ for Summer New Zealand Equities:




Example of how this applies to an investor

Kim had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Kim received a return after fund charges were deducted but before tax of \$2,474 (that is 24.74% of her initial \$10,000). Kim also paid \$36 in other charges. This gives Kim a total return after tax of \$2,313 for the year.
