This fund update was first made publicly available on 8 February 2023.

What is the purpose of this update?

This document tells you how Summer Balanced Selection has performed and what fees were charged. The document will help you to compare the fund with other funds. Forsyth Barr Investment Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

We aim to achieve positive longer-term returns by choosing a balanced mix of cash, fixed interest, equity and property investments. Investors can expect moderate to high levels of movement up and down in value and to receive longer-term returns that are higher than those of the Summer Conservative Selection (but with more risk), and lower than those of the Summer Growth Selection (but with less risk).

What are the risks of investing?

Risk indicator for Summer Balanced Selection:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


How has the fund performed?¹

This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 31 December 2022.


Example of how this applies to an investor

Kim had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Kim incurred a loss after fund charges were deducted but before tax of \$928 (that is -9.28% of her initial \$10,000). Kim also paid \$36 in other charges. This gives Kim a total loss after tax of \$953 for the year.

The top 10 investments make up 23.32% of the fund.

Foreign currency exposures associated with international fixed interest are hedged to the New Zealand dollar. We actively manage the fund's foreign currency exposures associated with international and Australian equities, and listed property. As at 31 December 2022, these exposures represented 37.40% of the value of the fund. After allowing for foreign currency hedges in place, 20.65% of the value of the fund was unhedged and exposed to foreign currency risk.
