What is the purpose of this update?

Description of this fund

What are the risks of investing?

Risk indicator for Summer Listed Property:




Example of how this applies to an investor

Kim had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Kim received a return after fund charges were deducted but before tax of \$538 (that is 5.38% of her initial \$10,000). Kim also paid \$36 in other charges. This gives Kim a total return after tax of \$444 for the year.

The top 10 investments make up 87.55% of the fund.

We actively manage the fund's foreign currency exposures. As at 31 December 2023, the fund's foreign currency represented 5.76% of the value of the fund. After allowing for foreign currency hedges in place, approximately 3.67% of the value of the fund was unhedged and exposed to foreign currency risk.
