## Summer Listed Property

Fund Update as at 30 June 2022

This fund update was first made publicly available on 27 July 2022.

### What is the purpose of this update?

This document tells you how Summer Listed Property has performed and what fees were charged. The document will help you to compare the fund with other funds. Forsyth Barr Investment Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

The fund invests in selected listed property vehicles. We aim to achieve positive long-term returns. These kinds of investments will typically have high levels of movement up and down in value.

### What are the risks of investing?

Risk indicator for Summer Listed Property:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

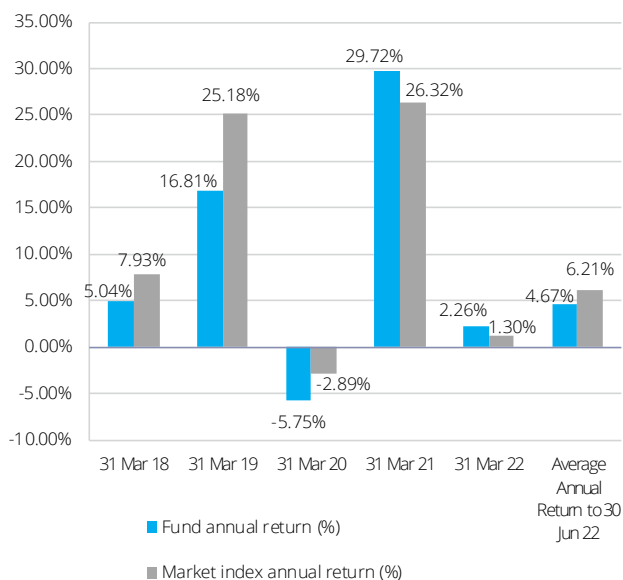

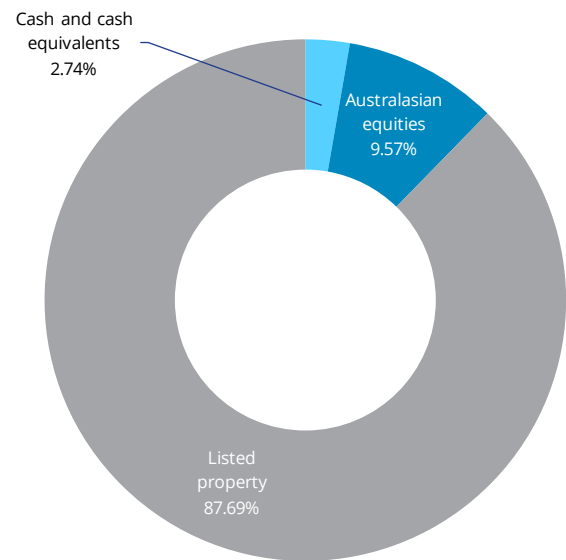
### Example of how this applies to an investor

Kim had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Kim incurred a loss after fund charges were deducted but before tax of \$1,284 (that is -12.84% of her initial \$10,000). Kim also paid \$36 in other charges. This gives Kim a total loss after tax of \$1,355 for the year.

The top 10 investments make up 83.85% of the fund.

We actively manage the fund's foreign currency exposures. As at 30 June 2022, the fund's foreign currency represented 9.80% of the value of the fund. After allowing for foreign currency hedges in place, approximately 6.11% of the value of the fund was unhedged and exposed to foreign currency risk.
