What is the purpose of this update?

This document tells you how Summer New Zealand Equities has performed and what fees were charged. The document will help you to compare the fund with other funds. Forsyth Barr Investment Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund invests mostly in selected New Zealand shares, and in Australian listed shares, where the company has meaningful operations in New Zealand. We aim to achieve positive long-term returns. These kinds of investments will typically have high levels of movement up and down in value.

What are the risks of investing?

Risk indicator for Summer New Zealand Equities:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

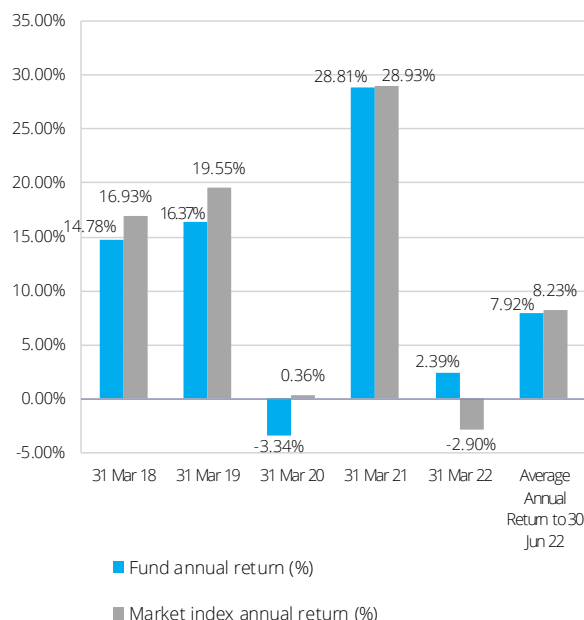

How has the fund performed?¹

Small differences in fees and charges can have a big impact on your investment over the long term.

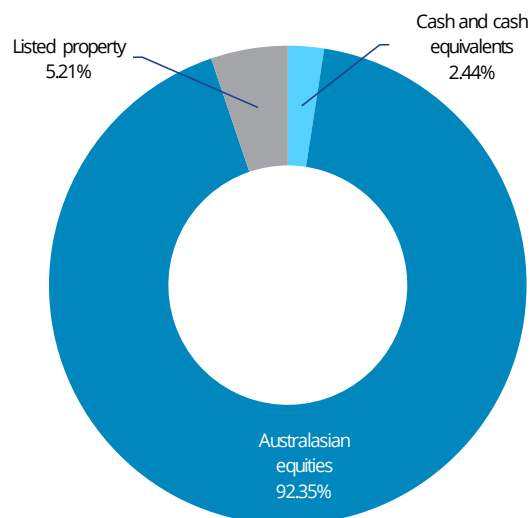
Example of how this applies to an investor

Kim had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Kim incurred a loss after fund charges were deducted but before tax of \$869 (that is -8.69% of her initial \$10,000). Kim also paid \$36 in other charges. This gives Kim a total loss after tax of \$972 for the year.
