### Fund Update as at 30 June 2023

This fund update was first made publicly available on 28 July 2023.

## What is the purpose of this update?

This document tells you how Summer Global Fixed Interest has performed and what fees were charged. The document will help you to compare the fund with other funds. Forsyth Barr Investment Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

The fund invests in selected international fixed interest assets. We aim to achieve positive long-term returns. These kinds of investments will typically have low to moderate levels of movement up and down in value.

## What are the risks of investing?

Risk indicator for Summer Global Fixed Interest:

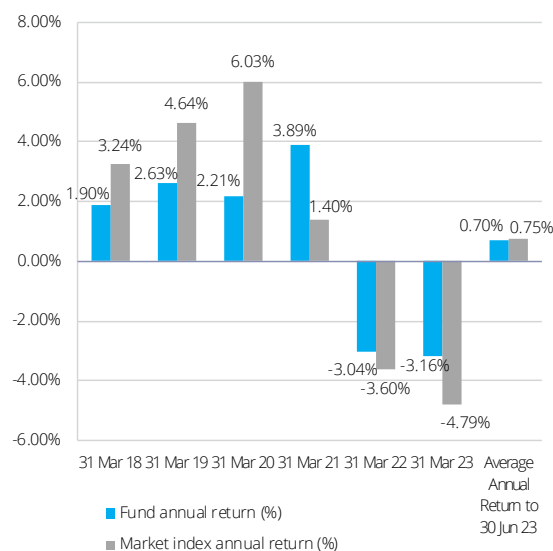

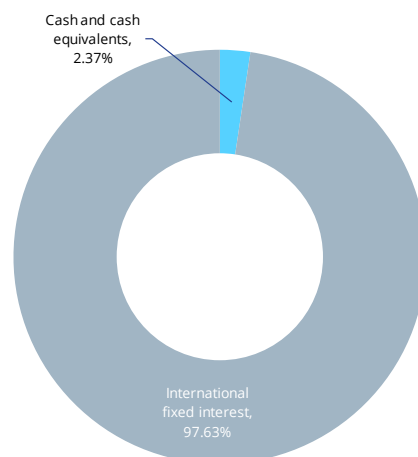
### Example of how this applies to an investor

Kim had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Kim received a return after fund charges were deducted but before tax of \$84 (that is 0.84% of her initial \$10,000). Kim also paid \$36 in other charges. This gives Kim a total return after tax of \$55 for the year.

We generally hedge the fund's foreign currency exposures associated with international fixed interest. As at 30 June 2023, these exposures represented 97.63% of the value of the fund and were fully hedged to the New Zealand dollar.

- <sup>2</sup> Summer Global Fixed Interest's primary investments are units in Smartshares Global Bond ETF (NZX ticker code GBF.NZ), a listed portfolio investment entity (PIE) assessed for taxable income at a fixed prescribed investment rate (PIR) of 28%. In certain circumstances this tax arrangement may be beneficial for investors assessed for taxable income at a lower PIR than 28% when compared to those investors' tax circumstances associated with a multi-rate PIE.
- <sup>3</sup> The account fee is charged at \$3 per member, per month.
- <sup>4</sup> Octagon Asset Management Limited is responsible for the day-to-day investment decisions for the fund.
