
Description of this fund

The fund invests in cash, selected cash equivalents and selected short-term New Zealand fixed interest assets. We aim to achieve competitive returns compared to money held on call. These kinds of investments will typically have lower returns and very low levels of movement up and down in value.




Example of how this applies to an investor

Kim had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Kim received a return after fund charges were deducted but before tax of \$19 (that is 0.19% of her initial \$10,000). Kim also paid \$36 in other charges. This gives Kim a total loss after tax of \$22 for the year.
