What is the purpose of this update?

What are the risks of investing?




Example of how this applies to an investor

Kim had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Kim incurred a loss after fund charges were deducted but before tax of \$236 (that is -2.36% of her initial \$10,000). Kim also paid \$36 in other charges. This gives Kim a total loss after tax of \$340 for the year.

We generally hedge the fund's foreign currency exposures associated with international fixed interest. As at 31 March 2022, these exposures represented 96.99% of the value of the fund and were fully hedged.
