What is the purpose of this update?





Example of how this applies to an investor

Kim had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Kim received a return after fund charges were deducted but before tax of \$269 (that is 2.69% of her initial \$10,000). Kim also paid \$36 in other charges. This gives Kim a total return after tax of \$190 for the year.

We actively manage the fund's foreign currency exposures. As at 31 March 2022, the fund's foreign currency represented 11.59% of the value of the fund. After allowing for foreign currency hedges in place, approximately 7.60% of the value of the fund was unhedged and exposed to foreign currency risk.
