### What is the purpose of this update?

This document tells you how Summer New Zealand Equities has performed and what fees were charged. The document will help you to compare the fund with other funds. Forsyth Barr Investment Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

The fund invests mostly in selected New Zealand shares, and in Australian listed shares, where the company has meaningful operations in New Zealand. We aim to achieve positive long-term returns. These kinds of investments will typically have high levels of movement up and down in value.

### What are the risks of investing?

Risk indicator for Summer New Zealand Equities:




### Example of how this applies to an investor

Kim had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Kim received a return after fund charges were deducted but before tax of \$314 (that is 3.14% of her initial \$10,000). Kim also paid \$36 in other charges. This gives Kim a total return after tax of \$203 for the year.
