# What is the purpose of this update?

This document tells you how Summer Global Equities has performed and what fees were charged. The document will help you to compare the fund with other funds. ## What are the risks of investing?




#### Example of how this applies to an investor

Kim had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Kim incurred a loss after fund charges were deducted but before tax of \$366 (that is -3.66% of her initial \$10,000). Kim also paid \$36 in other charges. This gives Kim a total loss after tax of \$372 for the year.

The top 10 investments make up 52.87% of the fund.

We actively manage the fund's foreign currency exposures. As at 31 March 2023, these exposures represented 97.19% of the value of the fund. After allowing for foreign currency hedges in place, 46.86% of the value of the fund was unhedged and exposed to foreign currency risk.
