

# Summer KiwiSaver Scheme

## Summer Growth Selection

Fund Update as at 31 March 2024

This fund update was first made publicly available on 29 April 2024.

### What is the purpose of this update?

This document tells you how Summer Growth Selection has performed and what fees were charged. The document will help you to compare the fund with other funds. Forsyth Barr Investment Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

We aim to achieve positive long-term returns by choosing a lesser exposure to cash and fixed interest investments and a greater exposure to equity and property investments. Investors can expect high levels of movement up and down in value and to receive longer-term returns that are higher than those of the Summer Balanced Selection (but with more risk).

### What are the risks of investing?

Risk indicator<sup>1</sup> for Summer Growth Selection:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

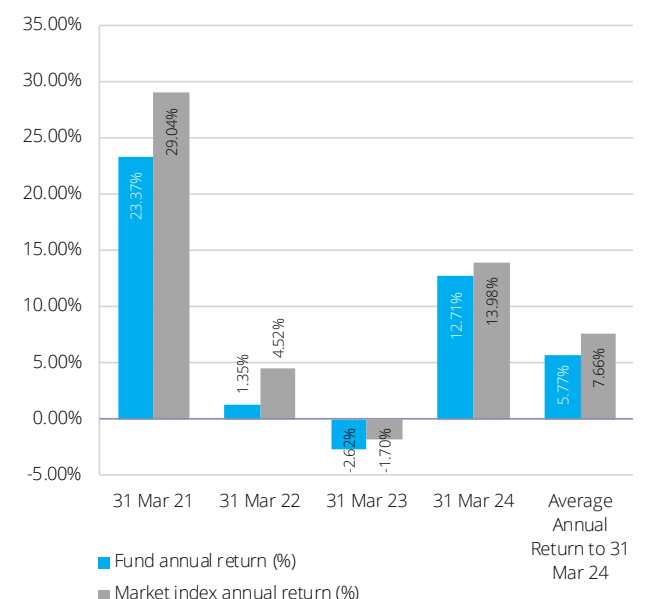

Investors may also be charged individual action fees for specific actions or decisions (for example for withdrawing from or switching funds), although these are not currently charged. Small differences in fees and charges can have a big impact on your investment over the long term.

### Example of how this applies to an investor

Kim had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Kim received a return after fund charges were deducted but before tax of \$1,374 (that is 13.74% of her initial \$10,000). Kim also paid \$36 in other charges. This gives Kim a total return after tax of \$1,235 for the year.

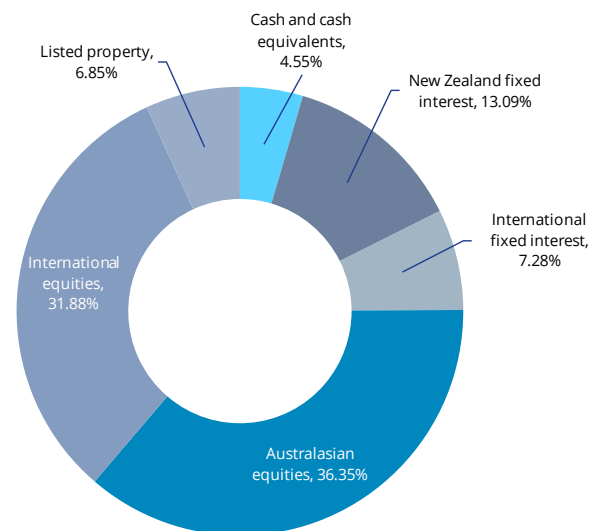
The top 10 investments make up 30.77% of the fund.

Foreign currency exposures associated with international fixed interest are hedged to the New Zealand dollar. We actively manage the fund's foreign currency exposures associated with international and Australian equities, and listed property. As at 31 March 2024, these exposures represented 52.39% of the value of the fund. After allowing for foreign currency hedges in place, 26.70% of the value of the fund was unhedged and exposed to foreign currency risk.

We've calculated the risk indicator using market index returns data for periods before that date, and actual fund returns data afterwards.
