Fund Update as at 31 March 2025

This fund update was first made publicly available on 1 May 2025.

What is the purpose of this update?

This document tells you how Summer Australian Equities has performed and what fees were charged. The document will help you to compare the fund with other funds. Forsyth Barr Investment Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Summer Australian Equities fund invests mostly in Australian shares, and can invest in New Zealand listed shares where the company has meaningful operations in Australia. We aim to achieve long-term returns (before fees, taxes and other expenses) greater than the S&P/ASX 200 Accumulation Index, 50% hedged to the New Zealand dollar.

What are the risks of investing?

Risk indicator for Summer Australian Equities:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

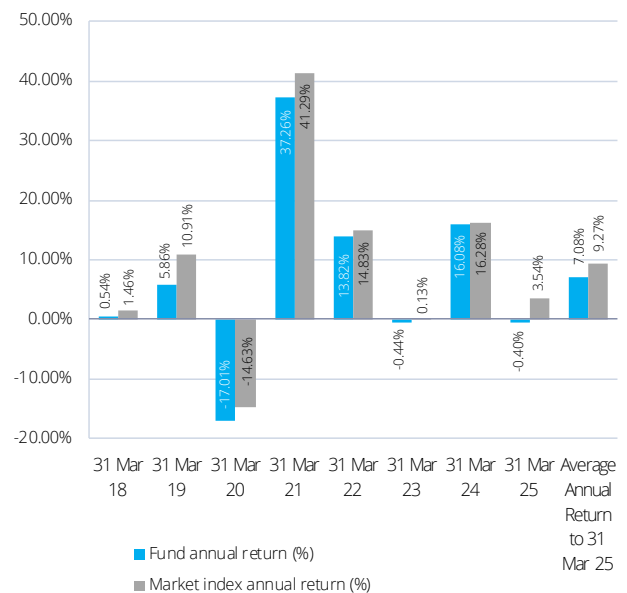

How has the fund performed?¹

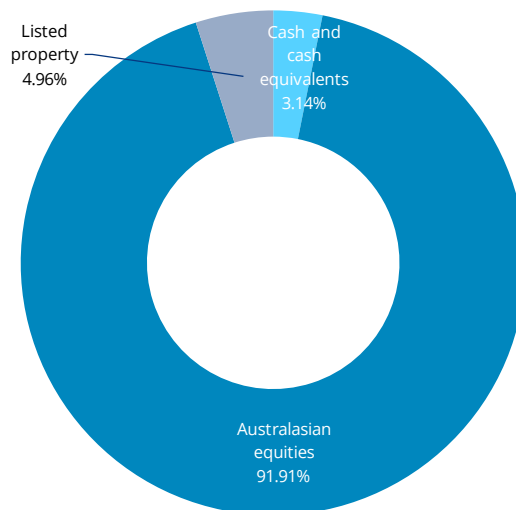
Example of how this applies to an investor

Kim had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Kim received a return after fund charges were deducted but before tax of \$46 (that is 0.46% of her initial \$10,000). Kim also paid \$36 in other charges. This gives Kim a total loss after tax of \$76 for the year.

The top 10 investments make up 41.86% of the fund.

We actively manage the fund's foreign currency exposures. As at 31 March 2025, these exposures represented 97.98% of the value of the fund. After allowing for foreign currency hedges in place, 55.53% of the value of the fund was unhedged and exposed to foreign currency risk.
