#### What is the purpose of this update?

This document tells you how Summer New Zealand Equities has performed and what fees were charged. The document will help you to compare the fund with other funds. Forsyth Barr Investment Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### Description of this fund

The Summer New Zealand Equities fund invests mostly in New Zealand shares, and can invest in Australian listed shares where the company has meaningful operations in New Zealand. We aim to achieve long-term returns (before fees, taxes and other expenses) greater than the S&P/NZX50 Gross with Imputation Index.

#### What are the risks of investing?




#### Example of how this applies to an investor

Kim had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Kim incurred a loss after fund charges were deducted but before tax of \$13 (that is -0.13% of her initial \$10,000). Kim also paid \$36 in other charges. This gives Kim a total loss after tax of \$141 for the year.
