What is the purpose of this update?

This document tells you how Summer New Zealand Fixed Interest has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

The Summer New Zealand Fixed Interest fund invests in New Zealand fixed interest assets. We aim to achieve long-term returns (before fees, taxes and other expenses) greater than the Bloomberg NZBond Composite 0+ Yr Index.

What are the risks of investing?

Risk indicator for Summer New Zealand Fixed Interest:




Example of how this applies to an investor

Kim had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Kim received a return after fund charges were deducted but before tax of \$594 (that is 5.94% of her initial \$10,000). Kim also paid \$36 in other charges. This gives Kim a total return after tax of \$391 for the year.
