What is the purpose of this update?

This document tells you how Summer Investment Selection¹ has performed and what fees were charged. The document will help you to compare the fund with other funds. Forsyth Barr Investment Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

We choose the exposure to the following asset classes for you: New Zealand Cash, New Zealand Fixed Interest, International Fixed Interest, New Zealand Equities, Australian Equities, Listed Property, and International Equities. We aim to achieve positive long-term returns. These kinds of investments will typically have moderate to high levels of movement up and down in value.

What are the risks of investing?

Risk indicator² for Summer Investment Selection:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

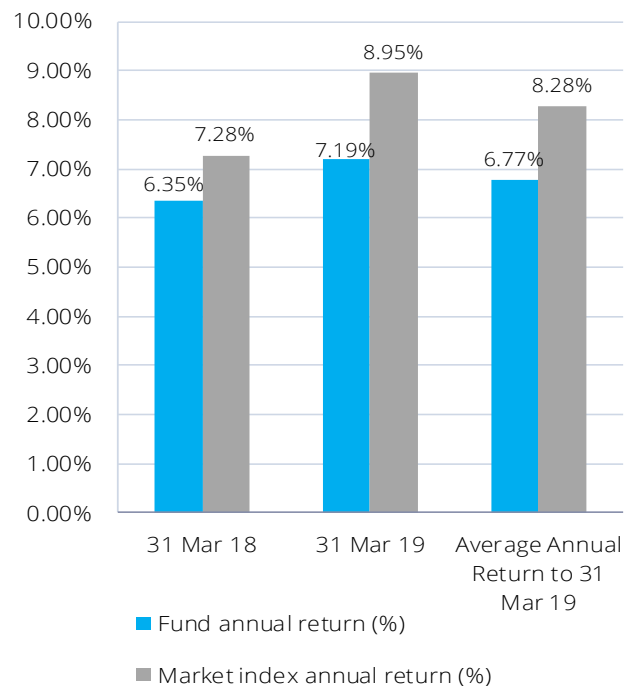

How has the fund performed?³

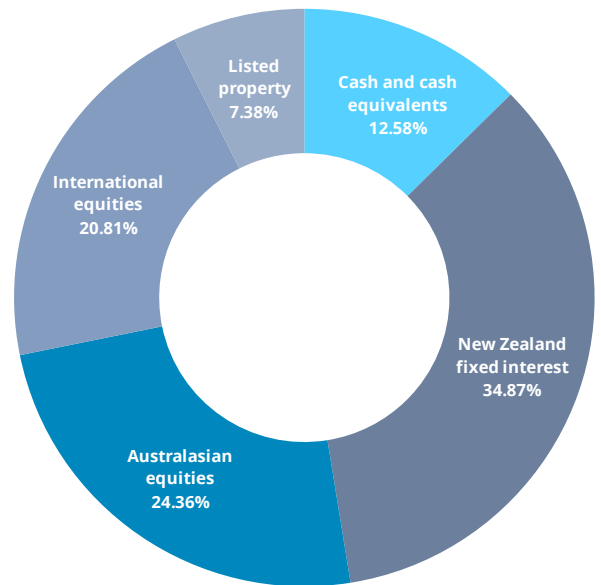
Example of how this applies to an investor

Kim had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Kim received a return after fund charges were deducted but before tax of \$837 (that is 8.37% of her initial \$10,000). Kim also paid \$36 in other charges. This gives Kim a total return after tax of \$683 for the year.

The top 10 investments make up 22.35% of the fund.

We actively manage the fund's foreign currency exposures. As at 31 March 2019, these exposures represented 33.75% of the value of the fund. After allowing for foreign currency hedges in place, 30.47% of the value of the fund was unhedged and exposed to foreign currency risk.

- ¹ On the 8 April 2019 the Summer Investment Selection was renamed the Summer Balanced Selection.
- ² This fund came into existence on 16 September 2016. We've calculated the risk indicator using market index returns data for periods before that date, and actual fund returns data afterwards. Using market index returns data may make the risk indicator a less reliable indicator of how much fund values might go up and down in future.
