# Summer Balanced Selection

Fund Update as at 30 September 2022



This fund update was first made available on 13 December 2022. It is a replacement fund update for the update made publicly available on 27 October 2022. The statements on foreign currency exposures have been corrected.

# What is the purpose of this update?

This document tells you how Summer Balanced Selection has performed and what fees were charged. The document will help you to compare the fund with other funds. Forsyth Barr Investment Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

# Description of this fund

We aim to achieve positive long-term returns by choosing a mix of cash, fixed interest, equity and property investments. Investors can expect moderate to high levels of movement up and down in value and to receive longer-term returns that are higher than those of the Summer Conservative Selection but lower than those of the Summer Growth Selection.

# What are the risks of investing? Risk indicator for Summer Balanced Selection:


# How has the fund performed?


#### Example of how this applies to an investor

Kim had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Kim incurred a loss after fund charges were deducted but before tax of \$1,019 (that is -10.19% of her initial \$10,000). Kim also paid \$36 in other charges. This gives Kim a total loss after tax of \$986 for the year.

The top 10 investments make up 21.98% of the fund.

Foreign currency exposures associated with international fixed interest are hedged to the New Zealand dollar. We actively manage the fund's other foreign currency exposures. As at 30 September 2022, these exposures represented 36.95% of the value of the fund. After allowing for foreign currency hedges in place, 16.76% of the value of the fund was unhedged and exposed to foreign currency risk.
