What is the purpose of this update?

This document tells you how Summer Global Fixed Interest has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

The fund invests in selected international fixed interest assets. We aim to achieve positive long-term returns. These kinds of investments will typically have low to moderate levels of movement up and down in value.

What are the risks of investing? Risk indicator for Summer Global Fixed Interest:




Example of how this applies to an investor

Kim had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Kim incurred a loss after fund charges were deducted but before tax of \$842 (that is -8.42% of her initial \$10,000). Kim also paid \$36 in other charges. This gives Kim a total loss after tax of \$886 for the year.

We generally hedge the fund's foreign currency exposures associated with international fixed interest. As at 30 September 2022, these exposures represented 98.79% of the value of the fund and were fully hedged to the New Zealand dollar.
