Summer Global Fixed Interest

Fund Update as at 30 June 2018

This fund update was first made publicly available on 3 August 2018.

It is a replacement fund update for the update made publicly available on 27 July 2018. The only change is to clarify that the total management and administration charges in the section headed "What fees are investors charged?" are actual, not estimated, figures.

What is the purpose of this update?

This document tells you how Summer Global Fixed Interest has performed and what fees were charged. The document will help you to compare the fund with other funds. Forsyth Barr Investment Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund invests in selected international fixed interest assets. We aim to achieve positive long-term returns. These kinds of investments will typically have low to moderate levels of movement up and down in value.

What are the risks of investing?

Risk indicator¹ for Summer Global Fixed Interest:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

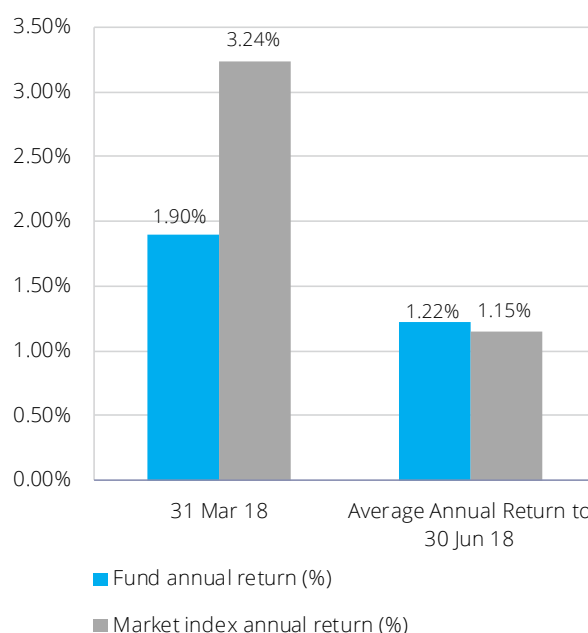

How has the fund performed?²

This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 30 June 2018.

Small differences in fees and charges can have a big impact on your investment over the long term.

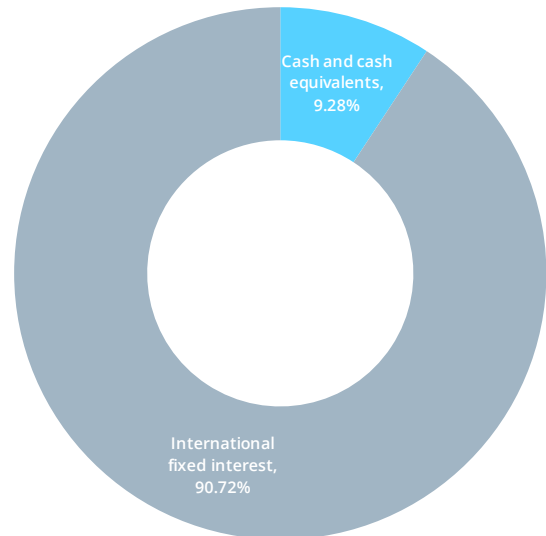
Example of how this applies to an investor

Kim had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Kim received a return after fund charges were deducted but before tax of \$164 (that is 1.64% of her initial \$10,000). Kim also paid \$36 in other charges. This gives Kim a total return after tax of \$77 for the year.

We generally hedge the fund's foreign currency exposures. As at 30 June 2018, these exposures represented 91.05% of the value of the fund and were fully hedged.
